### **Public Works Report**

Nunberg reviewed the monthly financial report for July and her monthly written report. A proposal was reviewed from Western Edge Roofing for repairs at City Hall. Benes requested references for the company be provided at the next meeting.

### **Committee Reports:**

Lautenschlager reported on the new building project at the Beach Airport.

### **New Business:**

Applications for Special Events on August 18<sup>th</sup> and 24<sup>th</sup> submitted by the American Legion were reviewed. Benes moved to approve the special events, second by Larson. Gerving abstained. Motion carried unanimously. An Application for Raffle submitted by the Beach Area Chamber of Commerce was reviewed. Lautenschlager moved to approve the raffle, second by Benes.

Motion carried unanimously. Three Applications for Blighted Building Demotion Grants were reviewed. Benes moved to approve all Applications in the amount of \$1000, second by Gerving. Marman abstained. Motion carried unanimously. Correspondence from Dickinson Area Chamber of Commerce, ND Association of Oil & Gas Producing Counties, Samuel Lockhart, and DeeAnn Baertsch was read. Recently it was discovered that in 1952 the city was deeded .94 acre in Glenhaven Addition, a portion of Blocks 20-22. Discussion. Marman moved to deed this .94 acre back to Gary Farstveet, second by Lautenschlager. Motion carried unanimously. Also discussed was the ownership of the Wye, which was abandoned in 2002 when Main Street was extended straight to Hwy 16. Gerving moved to deed the Wye to William Tidball as was verbally agreed upon at the time, if it is legally viable. Motion died for lack of second. Nunberg will consult the City Attorney.

No other business was brought forward. Lautenschlager moved to adjourn, second by Benes. Meeting adjourned at 8:15 p.m.
