A regular meeting of the Beach City Council was called to order by Mayor Walter Losinski at 7:00 pm on June 4, 2012. Sheriff' Report

Sheriff Steele presented the monthly report consisting of 27 calls, 8 citations and 1 written warning.

Public Works & Auditor's Report

PWS Beach reported on street repairs, sign replacement projects and mowing. Beach provided an estimate from Capital Paving and Seal Coating on three areas he would like to have paved. Marman moved to approve area #3 totaling \$46,410, second by Benes. Lautenschlager – yes, Gerving – no, Marman – yes, Benes – yes, Larson – yes, Walworth – no. Motion carried. Marman moved to approve area #2. Motion died for lack of second. Walworth moved approve area #2 totaling \$82,410 and request Farmers Union/Cenex cost share \$10,000 of the project, second by Gerving. Motion carried unanimously. Beach mentioned two property owners in the NW area have requested milling for the street. No decision was made at this time; it will be discussed at the next meeting. Nunberg provided her written report and reviewed the financial report for the month of May.

Committee Reports:

Garbage/Recycling - Walworth recommended purchasing a new baler. Also, due to the increase of materials being recycled, consider hiring an additional employee. Gerving moved to approve the purchase of a new baler, second by Benes. Motion carried unanimously.

Public Recreation - Nunberg reported on the Fishing Pond Project has been completed.

Unfinished Business:

Fire Chief Buchholz returned for a decision on the request for funds for the new excavation unit. Discussion. Gerving moved to amend the General Fund Fire Department budget from \$15,000 to \$65,000 and provide \$50,000 for the purchase of the new excavation unit, second by Walworth. Motion carried unanimously.

New Business:

An Application for Raffle submitted by Beach Close Up was reviewed. Walworth moved to approve the raffle, second by Benes. Motion carried unanimously. An Application for Special Events submitted by American Legion Club was reviewed. Walworth moved to approve the special event, second by Benes. Gerving abstained. Motion carried. An Application for Blighted Building Demolition Grant was reviewed. Gerving moved to approve the Blighted Building Grant request, second by Larson. Motion carried unanimously. Thank you correspondence from FBLA was read.

No other business was brought forward. Walworth moved to adjourn, second by Larson. Meeting adjourned at 8:30 p.m.
