Correspondence from Domestic Violence & Rape Crisis Center was read. Recommendations from the Zoning Board were reviewed. Benes moved to approve the recommendations given by the Zoning Board, second by Lautenschlager. Discussion. Motion carried unanimously.

No other business was brought forward. Benes moved to adjourn, second by Marman. Meeting adjourned at 8:00 p.m.
