Correspondence was read from Armando Muruato requesting permission to connect to the city water service. Walworth moved to approve the request, second by Larson. Motion carried unanimously.

No other business was brought forward. Benes moved to adjourn, second by Walworth. Meeting adjourned at 7:35 p.m.
