Nunberg provided the financial report for the month of March. Benes moved to approve, second by Larson. Motion carried unanimously.

Jon Dahl representing the Beach Park Board requested their annual amount of \$40,000 from the Pool Tax Fund for the upcoming summer operations. Benes moved to approve the request given in two payments of \$20,000, second by Larson. Motion carried unanimously.

An Application for Fireworks submitted by Gary VanVleet was reviewed. Benes moved to approve the application, second by Larson. Motion carried unanimously. An Application for Special Events submitted by the Backyard was reviewed. Walworth moved to approve contingent on two security personnel being provided, second by Benes. Motion carried unanimously. Nunberg reviewed Renaissance Zone Projects Bea-21 & Bea-22. Stockwell moved to approve both Renaissance Zone Projects, second by Walworth. Motion carried unanimously. The Annual Prairie West Development Foundation Report was provided. Correspondence was read from the ND DOT and the City of Bowman. No other business was brought forward. Walworth moved to adjourn, second by Larson carried unanimously. Meeting adjourned at 7:55 p.m.
