Al Begger, representing the Beach Zoning Board provided a recommendation for the City Council to continue working with Verizon Wireless to find an alternate site for the cell tower that would provide at least 150' from residential zoning. Begger explained the Zoning Board's recommendation was based on concerns expressed by two property owners at the Public Hearing held February 17th. Verizon Representative, Darrin Wixio mentioned they have been working with a number of people from the city for over a year to determine a feasible site in Beach to construct a cell tower. Wixio explained the site chosen has been cleared by FAA, FCC and now is awaiting city approval to proceed. If a new site has to be considered, it would be an estimated 5 years before being looked at again. Discussion. Marman moved to reject the recommendation by the Zoning Board and to approve the Commercial Building Permit with Conditional Use for Verizon Wireless, second by Walworth. Marman-yes, Walworth-yes, Benes-yes, Larson-yes, Stockwell-yes. Motion carried unanimously.

The Council reviewed the monthly Sheriff's Report for February consisting of 17 calls, 1 written warning and 4 citations. PWS Beach reported on snow removal. Nunberg provide a preliminary financial report for the month of February.

Marman moved to approve the Final Reading of Ordinance 367, second by Walworth. Motion carried unanimously.

ORDINANCE NO. 367

AN ORDINANCE TO REPEAL SECTIONS 14.0701 AND 14.0702, OF THE 2009
REVISED ORDINANCES OF THE CITY OF BEACH, NORTH DAKOTA,
RELATING TO WASTE WATER BACKUP CLAIMS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEACH, NORTH
DAKOTA, AS FOLLOWS:

Section 1. Repeal. Sections 14.0701 and 14.0702 of the 2009 Revised Ordinances of the
City of Beach, North Dakota, are hereby repealed.

Section 2. Effective date. This ordinance shall be in full force and effect from and after
its final passage and adoption.
