**ORDINANCE NO. 367**

AN ORDINANCE TO REPEAL SECTIONS 14.0701 AND 14.0702, OF THE 2009  
REVISED ORDINANCES OF THE CITY OF BEACH, NORTH DAKOTA,  
RELATING TO WASTE WATER BACKUP CLAIMS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEACH, NORTH  
DAKOTA, AS FOLLOWS:

Section 1. Repeal. Sections 14.0701 and 14.0702 of the 2009 Revised Ordinances of the City of Beach, North Dakota, are hereby repealed.

Section 2. Effective date. This ordinance shall be in full force and effect from and after its final passage and adoption.
