A regular meeting of the Beach City Council was called to order by Mayor Losinski at 7:00 pm on December 7, 2009. Present when the meeting was called to order was Council Tim Marman, Perry Stockwell, Jeanne Larson, Wade Walworth, Josh Wirtzfeld, PWS Dell Beach, Public Works Kent Shaw, City Auditor Kimberly Nunberg and Sheriff Scot Steele.

Sheriff Scot Steele presented the monthly report for November consisting of 23 calls, 7 written warnings and 4 citations.

PWS Beach reported on tree stump removal being done. PACE Construction will be here next week cleaning more sewer lines. A Wastewater Backup Claim submitted by Wade Szudera was reviewed. Discussion. Marman moved to pay Szudera's for the bill from Steam Brothers in the amount of \$2,084.56 for cleaning and review the remaining claim, second by Larson. Motion carried unanimously.

Nunberg reviewed the financial statement for the month of November and amendments needed to the 2009 budget. Wirtzfeld moved to approve the November financial statement, second by Walworth. Motion carried unanimously. Walworth moved to amend the Wastewater Fund to include an expenditure of \$3000.00, second by Wirtzfeld. Motion carried unanimously. Walworth moved to amend the Fire Department General Fund an additional \$35,000 due to increase in expenditures, second by Wirtzfeld. Motion carried unanimously.

Mayor Losinski mentioned Nunberg will be gone for the next meeting and with the lack of business suggested cancelling the next meeting. Marman moved to cancel the meeting on December 21, second by Larson. Motion carried unanimously. Next regular meeting will be January 4, 2010. Walworth moved to give each full time employee \$100 in Beach Bucks and part time employees \$50 in Beach Bucks, second by Wirtzfeld. Motion carried unanimously. Stockwell was excused from the meeting.

Correspondence from the ND Health Department regarding the Beach Inert Landfill was presented. Renaissance Zone Project 18-Bea was reviewed. Walworth moved to approve Renaissance Zone Project 18-Bea, second by Larson. Motion carried unanimously. Nunberg reviewed an Energy Efficiency Community Block Grant (EECBG) for the City Shop. Wirtzfeld moved to submit application to the ND Department of Commerce for the EECBG, second by Walworth. Motion carried unanimously. Nunberg presented information on a discount prescription card available to city residents since the city is a member of the National League of Cities. Walworth moved to submit application for participation in the prescription discount program, second by Wirtzfeld. Motion carried unanimously.

No other business was brought forward. Larson moved to adjourn, second by Walworth. Motion carried unanimously. Meeting adjourned at 8:00 p.m.
