Stockwell-yes, Larson-yes, Benes-yes, Marman-no. Motion carried. An Application for Property Tax Exemption for Improvement to Commercial and Residential Buildings was reviewed. Benes moved to approve the application, second by Marman. Motion carried unanimously.

No other business was brought forward. Benes moved to adjourn, second by Stockwell. Motion carried unanimously. Meeting adjourned at 7:35 p.m.
