Amend City Occupancy Fund FICA from \$500.00 to \$541.00.
Amend City Occupancy Fund Medicare from \$120.00 to \$127.00.

Engineer Report

Engineer Klein reviewed his written report which included; 2023 Street & Utility Improvements, Beach Dam Rehab Project, Clean Water State Revolving Fund Projects and Gazebo Park Vision and Planning Support. Swanson-Puckett moved to approve the scope of services and fee for the Gazebo Park Vision and Planning Support Project, second by Ross. Motion carried unanimously.
