Engineer Ranisate's written report was reviewed. The Beach Dam Rehab Project is currently in the study and preliminary engineering phase. The 2023 Street & Utility Improvement Project

will be able to move forward with the Preliminary Engineering Report once the televising of sewer lines has been completed. The Quiet Zone Affirmation Letter was submitted two months ago and still under review. FEMA Funding for the 2<sup>nd</sup> Street SW Road Repair may be available but we will not know for sure until sometime in August. Estimated cost of repair is \$140,000.00.

Meter reading system upgrade – Additional information is needed. PWS Dietz will follow up with the sales representative from Core & Main.

An Application for Special Events Permit submitted by Golden Valley County Fair Association was reviewed. Zachmann moved to approve up to 3 consecutive days, second by Ross. Motion carried unanimously.

No other business was brought forward. Zachmann moved to adjourn, second by Wolff. Meeting adjourned at 8:15 p.m.
