

CITY COUNCIL PROCEEDINGS  
PUBLISHED SUBJECT TO THE GOVERNING BODY'S REVIEW AND REVISION

A regular meeting of the Beach City Council was called to order by Mayor Losinski on Monday, August 19, 2024 at 7:00 p.m. Present when the meeting was called to order was City Council Tom Marman, Lynn Swanson-Puckett, Sarah Ross, John Stonehocker, Bev Wolff, Andy Zachmann, Public Works Superintendent Randy Dietz, City Auditor Kimberly Gaugler, Sheriff Dey Muckle, Administrative Assistant Lea Massado and guest Corlene Olson.

The Pledge of Allegiance was recited.

Roll call was taken. All members were present.

Mayor Losinski called for any additions or corrections to the agenda. Zachmann moved to approve the agenda as presented, second by Wolff. Motion carried unanimously.

**Minutes**

Minutes of the meeting on August 5, 2024 were presented. Swanson-Puckett moved to approve the minutes, second by Zachmann. Motion carried unanimously.

**Sheriff's Report**

Sheriff Dey Muckle reviewed his written report for the month of July which consisted of 41 calls, 2 written citations and 7 warning citations. Sheriff Muckle addressed concerns on semi-trucks parking in residential areas. Zachmann moved to contact City Attorney Bouray and Southwestern District Health Unit regarding a public nuisance complaint, second by Swanson-Puckett. Motion carried unanimously.

**Public Works Report**

PWS Dietz reviewed his written report. Dietz mentioned the sanitation truck is in Dickinson for repairs. Alternative arrangements are being made for sanitation collection this week since we do not know how long we will be without our sanitation truck.

**Auditor's Report**

Gaugler reviewed her written report. Gaugler reviewed the financial report for the month of July. Zachmann moved to approve the financial report, second by Swanson-Puckett. Motion carried unanimously. Zachmann moved to approve payment on loan 278 in the amount of \$12,490.00 to Bank of North Dakota for Water Improvement District 2021-1, second by Swanson-Puckett. Motion carried unanimously.

**Committee Reports**

**Zoning** – Marman reported the Zoning Board met today. One Application for a Conditional Use was tabled and five Applications for Building were approved. Properties that are in non-compliance of setbacks or zoning use are being handled by City Attorney Bouray.

**Park Board** – Zachmann reported the Park Board met on August 12<sup>th</sup>. The swimming pool is wrapping up for the season.

There being no other business, Swanson-Puckett moved to adjourn, second by Zachmann.
