

A regular meeting of the Beach City Council was called to order by President Andy Zachmann on Tuesday, February 18, 2025 at 7:00 p.m. Present when the meeting was called to order was City Council Tom Marman, Sarah Ross, Lynn Swanson-Puckett, John Stonehocker, Bev Wolff (via telephone), Public Works Superintendent Randy Dietz, City Auditor Kimberly Gaugler, Administrative Assistant Lea Massado, guests Gary Howard and Jared Ross.

The Pledge of Allegiance was recited.

Roll call was taken. Mayor Losinski was absent.

President Zachmann called for any additions or corrections to the agenda. Ross moved to approve the agenda as presented, second by Marman. Motion carried unanimously.

**Minutes**

Minutes of the meeting on February 3, 2025 were presented. Ross moved to approve the minutes, second by Marman. Motion carried unanimously.

**Sheriff's Report**

Sheriff Muckle's written report was reviewed. The month of January consisted of 27 city calls, 0 written citation and 3 warning citations.

**Public Works Report**

PWS Dietz reported on system connections at well pump houses which will be repaired in the near future to eliminate any possibility of cross connections to the water system.

**Auditor's Report**

Gaugler reviewed her written report. Swanson-Puckett moved to approve the SRF 2021 Street & Utility Improvement Project annual interest and administration payment to the Bank of North Dakota in the amount of \$3,400.00, second by Stonehocker. Motion carried unanimously.

Gaugler reviewed the financial report for the month of January. Swanson-Puckett moved to approve the financial report, second by Ross. Motion carried unanimously. Swanson-Puckett moved to amend the 2025 General Fund Expense Budget to include a line item for the USDA Rural Business Development Grant in the amount of \$85,000, second by Ross. Motion carried unanimously.

**Committee Reports**

**Zoning** – Marman reported the Zoning Board met today. A Public Hearing was held regarding the preliminary plat of Hathaway Industrial Park Subdivision submitted by Farmers Union Oil Company. Updates needing to be made to the preliminary plat were identified. Two members of the Zoning Board and the City Engineer will meet with representatives from Farmers Union to review the updates needed. The next Zoning Board meeting will be March 17 at 8 a.m.

**New Business**

Correspondence was read from North Dakota Small Business Development Center highlighting the hard work, innovation and real impacts for small businesses across the State in 2024.

Correspondence was read from the Bank of North Dakota regarding security measures to protect customer's confidential information.

Correspondence was read from the Beach Post Prom Committee requesting a donation for prom 2025. Swanson-Puckett moved to approve donating \$500 from the Community Enhancement Fund, second by Ross. Motion carried unanimously.

Correspondence was read from Golden Valley County Director of Tax Equalization Carla Beeler regarding the Board of Equalization Meeting set for April 7 at 7:30 p.m.

An Application for Local Permit of a Raffle submitted by Golden Valley Pheasants Forever was reviewed. Swanson-Puckett moved to approve the permit, second by Stonehocker. Motion carried unanimously.

## **Auditor's Report**

### **Monday, March 3<sup>rd</sup>, 2025**

1. We continue to submit materials to our independent auditors, Point CPA, for audit review of year ending December 31, 2022.
2. The annual payment was made to Bank of ND for the SRF 2021 Street & Utility Improvement Project. Total payment made for interest and admin fee was \$3,400.00.
3. We've been working with a representative from North Dakota Insurance Reserve Fund to ensure all buildings are adequately insured. Valuation was increased on nine structures, mainly due to the increased cost of building.
4. We've ordered some of the equipment that was approved through a WSI Ergonomics Grant and have already been reimbursed on what was ordered. We are also in the process of ordering the equipment that was approved through a USDA Rural Business Development Grant for the Dobre Brewhouse expansion project.
5. Notice was received on February 27<sup>th</sup> from ND Commerce Division of Community Services that Renaissance Zone Project 34-Bea has been granted final approval. The five year exemption period will be February 2025 through January 2030.
6. As of February 28<sup>th</sup>, expenses for the year are \$269,751.25 and revenues collected are \$354,741.74. Twelve percent (12%) of the expense budget has been spent and sixteen percent (16%) of the revenue budget collected.
7. The Amended Cost Share Agreement with the State Water Commission for the upcoming Street & Utility Project was sent to Attorney Bouray for review, as is required. He has completed review of the agreement, the Mayor and I will sign the agreement and then return it to ND Drinking Water Resources.
8. The North Dakota League of Cities Spring Workshop & Elected Officials Training is March 19-20 in Bismarck. Please let me know if you plan to attend so lodging can be secured and registration submitted.
9. The annual report on Transportation Project Funding and Expenditures will be submitted to the Tax Commissioner be end of month. (NDCC 54-27-26)
10. As a North Dakota homeowner, you may qualify for a Property Tax Credit. Apply online at [tax.nd.gov/prc](http://tax.nd.gov/prc) by March 31<sup>st</sup>.
11. A number of community-building activities are being planned throughout City Government Week which is April 7-11. This is a special time for city leaders and staff to enhance public awareness of the role local government plays in the lives of citizen's every day. If you have suggestions for activities or would like to be involved in a particular way please let us know.
12. The City Council will meet as the Board of Equalization on April 7<sup>th</sup> at 7:30 p.m.
13. City offices will be closed on Friday, April 18<sup>th</sup> in observance of Good Friday.

**AMENDMENT I to the  
Agreement for Cost-Share Reimbursement  
City of Beach 2024  
Street and Utility Improvements**

**1. Background.** In April 2024, the State of North Dakota (State), by and through the State Water Commission (Commission), and the City of Beach (Sponsor) entered into the Agreement for Cost-Share Reimbursement City of Beach 2024 Street and Utility Improvements (Agreement).

**2. Intent.** The intent of the parties here is to amend the Agreement to provide an additional cost-share of up to \$3,160,110, to reimburse 60 percent of the actual eligible costs.

**3. Agreement.** Commission and Sponsor agree to amend the Agreement as follows:

- a. Replace all of the language in paragraph 3 (“**COMMISSION’S RESPONSIBILITY AND INTENT**”) with the following language:

Commission will provide Sponsor with cost-share, not to exceed \$3,377,663, as approved by Commission on April 11, 2024 (\$217,553) and February 13, 2025 (\$3,160,110) to reimburse 60 percent of actual eligible costs incurred in Sponsor's 2024 Street and Utility Improvements (Project), contingent on availability of funds and conditions of this agreement. Commission's intent in providing this funding to Sponsor is to assist Sponsor financially with Project costs. Sponsor retains sole and absolute discretion in the manner and means of carrying out Project, except to the extent specified in this agreement.

- b. Replace all of the language in paragraph 4 (“**SPONSOR’S RESPONSIBILITIES**”) subsection e. with the following language:

Comply with all North Dakota laws applicable to Project.

- c. Insert paragraph 17 (“**AUTHORITY TO SIGN**”) with the following language:

Each of the undersigned persons represents and warrants that he or she is fully authorized to enter into the terms and conditions of this Agreement, and execute this Agreement on behalf of the Party

or Parties he or she represents and further represents that he or she has explained this Agreement to the Party or Parties he or she represents and has obtained the agreement of each such Party to abide by the term and conditions of this Agreement.



Dear Ms. Gaugler:

Loan forgiveness funds have now become available within the Drinking Water State Revolving Fund (DWSRF) Program in North Dakota. The lead service line replacement components of the above-referenced project have been determined to be eligible to receive loan forgiveness in the amount of up to 66% of the eligible loan costs to the extent that loan forgiveness funds are available. These include eligible administrative costs, executed engineering agreements, and executed construction agreements. Based on a preliminary estimate of \$150,000 in eligible costs, the city is eligible for up to \$99,000 of loan forgiveness. The remaining \$51,000 must be covered by a DWSRF loan.

In order to ensure that loan forgiveness funds are used expeditiously, the project is required to meet the following deadlines:

1. Submit a first loan draw by September 30, 2025. The loan will need to be approved and all documents signed prior to this. Allow at least six weeks after submittal of the loan application for approval.
2. Issue the Notice of Award for the construction contract by November 30, 2025.
3. Use all loan forgiveness funds by September 30, 2030.

Written requests for deadline extensions may be considered. Should your project fail to meet a deadline, loan forgiveness dollars for the project may be reallocated to another project on the Project Priority List. Also, if you do not wish to pursue a DWSRF loan and loan forgiveness for your project, or if the project has already proceeded using other funding, please contact us so these funds can be allocated to other eligible projects.


