**PW Report:**

Robertson provided an estimate of \$123,375 for alley reconstruction on Block 2 of Original Townsite. No action was taken.

**New Business:**

An Application to Sell Fireworks submitted by Gary VanVleet was reviewed. Walworth moved to approve, second by Gerving. Motion carried unanimously.

Benes moved to designate Golden Valley News as the official newspaper for the City of Beach, second by Gerving. Gerving – yes, Beach – yes, Marman – yes, Benes – yes, Larson – yes, Walworth – no. Motion carried.

Thank you correspondence from FBLA was read.

No other business was brought forward. Gerving moved to adjourn, second Walworth. Meeting adjourned at 7:40 p.m.
