**PW Report:**

Braden reported on snow removal and water meters that have been installed.

**Auditor Report:**

Gaugler reviewed her written report. Gaugler reviewed the financial report for the month of February. Benes moved to approve the financial statement, second by Larson. Motion carried unanimously.

**Sheriff's Report:**

The Sheriff's Report for the month of February consisting of 13 calls, 0 citations and 1 written warning was reviewed.

**New Business:**

At 7:30 a Public Hearing was held for comment on an Application for Conditional Use Permit submitted by Bakken Development Fund for a bituminous plant to be located in the SE ¼ of Section 14 Township 140N Range 106W. Larson moved to open the Public Hearing for comment, second by Marman. Motion carried unanimously. Vent Wallace of Fisher Industries explained the site would be a staging area for a ND DOT paving project which goes 20 miles north of Beach on Highway 16. The bid date for the ND DOT project is April 13<sup>th</sup>. Estimated time for paving is 3-4 weeks with a completion date of 10/13/18. Information on material/equipment stored on site, probable traffic impact, and load restrictions was discussed. No other public comment was received. Marman moved to close the Public Hearing, second by Benes. Motion carried unanimously.

Marman moved to approve the Application for Conditional Use contingent on Fisher Industries receiving the contract for the ND DOT project, second by Benes. Motion carried unanimously.

Correspondence from ND Department of Health was read recognizing the City of Beach being compliant with the Safe Drinking Water Act.

Walworth moved to approve Resolution No. 2018-11, second by Larson. Motion carried unanimously.

**RESOLUTION NO. 2018-11**

**A RESOLUTION TO REFER TO THE QUALIFIED VOTERS OF THE CITY OF BEACH, THE QUESTION OF AMENDING AND INCREASING A MUNICIPAL SALES, USE AND GROSS RECEIPTS TAX**

**BE IT RESOLVED** by the governing body of the City of Beach, North Dakota (the "City"), as follows:

**WHEREAS**, the City Council of the City of Beach has in place and effect, a municipal sales use and gross receipts tax; and

**WHEREAS**, the City Council of the City of Beach wishes to refer to the qualified electors of the City of Beach, the question of whether to amend the existing tax to increase the tax rate from one percent, to one and one-half percent, and further to clarify that the tax applies to sales, use, and gross receipts, to make consistent with state law changes, to be placed on the ballot of the June 12, 2018 state wide election;

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Beach, North Dakota, hereby authorizes and directs the following measure to be placed on the ballot of the election to be held June 12, 2018:

The City of Beach is authorized by its Home Rule Charter to collect a one percent (1%) sales, use, and gross receipts tax. You are being asked whether to increase the one percent (1%) sales, use, and gross receipts tax to one and one-half percent (1.5%), to add language clarifying that the tax applies to gross receipts as defined by N.D.C.C. Ch. 57-39.5 & 57-39.6, and to continue in all other respects, without change, with the increase commencing October 1, 2018.

Shall the City of Beach increase the one percent (1%) city sales, use, and gross receipts tax to one and one-half percent (1.5%)?
