### **Public Works Report:**

PWS Braden reported the new summer landfill hours will be Tuesday, Thursday, Friday 4 -7pm, Saturday 10am – 2pm. Two weeks ago, PACE, Inc. cleaned and televised portions of the main line going to the lagoon. Once that televised information is available, the Engineer will review and prepare a Report to accompany the CDBG application. Street work will be starting soon. Summer help will be starting the end of May. Braden provided an estimate for leasing a mowing tractor. Marman moved to table this until the next meeting, second by Walworth. Motion carried unanimously.

### **Auditor Report:**

Nunberg reviewed her written report. The Application for Community Development Block Grant (CDBG) funds was reviewed. Once the Engineer's Report is complete the application will be submitted. Matching funds for the CDBG will come from the City Sales Tax Infrastructure Fund.

#### **Engineer Report:**

Robertson reported on the progress of the Street Improvement District 2016-2. Robertson will meet with the Street Committee on Friday to review the Preliminary Design.

#### **Police Committee:**

Walworth reported on meeting with the school administration at Lincoln Elementary regarding the request to establish a School Zone. Braden will order and install the necessary signs.

### **New Business:**

An Application for a Blighted Building Grant to be used at 229 First Avenue NW was reviewed. Marman moved to discontinue the Blighted Building Grant Program due to lack of revenues for the program, second by Walworth. Discussion. Beach – yes, Marman – yes, Walworth – yes, Gerving - no, Larson - no, Benes – no. Mayor Losinski voted yes. Motion carried.

An Application for Beer & Liquor License submitted by Golden Valley Fair Association was reviewed. Board Member Renae Smith was present to answer questions. Gerving moved to approve the Beer and Liquor License pending legal review, second by Walworth. Discussion.

Gerving – yes, Walworth – yes, Beach – yes, Marman – yes, Benes – yes, Larson – no. Motion carried.

Correspondence from Home on the Range was read.

Thank you correspondence from Bank of the West was read.

Mayor Losinski presented information from Farmers Union regarding a possible addition to the east side of the building. The information will be passed on to the Zoning Board.

No other business was brought forward. Walworth moved to adjourn, second Gerving. Meeting adjourned at 8:00 p.m.
