A regular meeting of the Beach City Council was called to order by Mayor Walter Losinski on February 1, 2016 at 7:00 pm. Public Works Report:

PWS Braden reported all the holiday decorations have been taken down, a portion of the Phase 1 Walking Trail has been blocked off until it is repaired in the Spring, if weather allows the tree pile at the landfill will be burned this week and there are only three water meter MXU's to be replaced yet.

Auditor Report:

Nunberg reviewed her written report. The application for Energy Infrastructure Impact Office for road projects was submitted on January 28th. The option to pay utility bills on the city website is now available. City Hall will be closed on February 15th to observe President's Day. Workforce Safety Insurance is conducting an assessment on City Hall for an ergonomics initiative. The City has been approved for a \$3,888,000 loan with the Bank of North Dakota for road projects in the NW and SE areas of the City. The City has until April 27, 2016 to accept or decline the loan. Nunberg provided information from Fire Chief Dan Buchholz on fire incident calls within the city for the year 2015.

Committee Reports:

Mayor Losinski presented information on the North Dakota Ready Mix and Concrete Association Banquet he attended January 21st. The City of Beach received the Gold Medal Award for the Phase 1 Multi Use Trail project.

Sheriff's Report

The monthly report for January 2016 was reviewed. January had a total of 20 calls, 4 citations and 3 written warnings.

Lagoon

Engineer Schmelzenbach reported this project is complete.

Multi Use Trail

Engineer Schmelzenbach mentioned the final walk through on Phase 1 Multi Use Trail was completed on January 20th. The remaining work on the street ramp/drainage issues along 6th Street NW will be corrected in the spring.

Unfinished Business:

Nunberg provided a breakdown of major projects completed in 2015 and reviewed the \$5,029,013 expenses incurred throughout the year. Discussion. Gerving moved to give Nunberg approval to negotiate and secure a \$300,000 loan from First State Bank of Golva to be used to reimburse the General Fund for costs already incurred on the lagoon expansion project, second by Walworth. Gerving – yes, Walworth – yes, Benes – yes Marman – yes, Larson – yes, Beach – yes. Motion carried unanimously.

New Business:

Correspondence from Southwest Water Authority was read regarding a Contract for Transfer of Service Area. A representative from Southwest Water Authority will attend our next available meeting to discuss the contract. Gerving moved to notify Southwest Water Authority we are not taking action at this time, second by Walworth. Motion carried unanimously. Correspondence from Southwest Water Authority was read regarding the twenty-one cent rate increase that went into effect in January. Correspondence from Roosevelt Custer Regional Council was read regarding \$212,050 of funds available for public facilities projects. Correspondence from North Dakota League of Cities was read.

No other business was brought forward. Walworth moved to adjourn, second by Gerving. Motion carried unanimously. Meeting adjourned at 8:15 p.m.
