**Public Works Report:**

Braden will obtain a proposal for the Council to consider at the next meeting. A broken sewer line at the intersection of 4<sup>th</sup> Street and 1<sup>st</sup> Ave SW was repaired. Braden reported on street repairs completed recently. Braden provided a proposal on oil for chip sealing. Gerving moved to approve the purchase of oil for chip sealing at an estimated cost of \$26,400, second by Benes. Motion carried unanimously.

**Auditor Report:**

Nunberg reviewed her written report. Correspondence from the State Auditor's Office regarding the recent audit findings was reviewed. Correspondence from Roosevelt Custer Regional Council was read.

**Committee Reports:**

Gerving expressed concerns with train horns sounding again within the Quiet Zone.

**New Business:**

The most recent version of the Southwest Pipeline Project Contract for Transfer of Service Area was provided to the Council. The document will be reviewed at the next meeting. An Application for Raffle submitted by Pheasants Forever Chapter #777 was reviewed. Walworth moved to approve the raffle, second by Larson. Motion carried unanimously. Correspondence from Golden Valley County Sheriff's Office regarding contract for services in 2017 was read. No other business was brought forward. Walworth moved to adjourn, second by Gerving. Motion carried unanimously. Meeting adjourned at 7:40 p.m.
