

CITY COUNCIL PROCEEDINGS

A regular meeting of the Beach City Council was called to order by Mayor Walter Losinski on February 3, 2014 at 7 p.m. Present when the meeting was called to order was City Council Paul Lautenschlager, Henry Gerving, Tim Marman, Mark Benes, Wade Walworth, Jeanne Larson, Public Works Superintendent Mike Braden, City Auditor Kimberly Nunberg, City Engineer Jon Wilczek, and guests Tom Togni, Jo Kimery, Vanessa Ueckert, Pat Lynch, Deb Walworth, and John Abraham.

**Public Participation:** John Abraham requested the Council re-consider the decision to enforce no parking along the west side of 2<sup>nd</sup> Ave NE. Discussion. Consensus was the decision of no parking would stay in effect. However, the Council is open to reviewing this decision at a later time if a need for parking develops.

**Sheriff's Report:**

Sheriff Steele was unable to attend the meeting but provided the monthly report for January consisting of 15 calls, 4 citations and 2 written warnings.

**Public Works Report:**

PWS Braden reported on snow removal and provided a quote for repairs on five manholes. The quote from SuperTec Infrastructure Technologies, Inc. was in the amount of \$32,622.00. Marman moved to approve the quote, second by Benes. Discussion. Motion carried unanimously.

**Auditor Report:**

Nunberg reviewed the financial report for the month of January. Benes moved to approve the financial report, second by Gerving. Motion carried unanimously.

**Committee Reports:**

**Lagoon Expansion Project:** At the last meeting Wilczek was asked to provide an estimate for a new mechanical plant system. Cost for a new mechanical plant system is \$8,549,000. Consensus was this is not cost feasible for the City. Wilczek provided an updated project cost of \$3.5 to \$3.7m to expand the current lagoon system. Wilczek will continue to work on design for an expanded lagoon system.

**Zoning:** Marman, Larson and Nunberg shared details of a recent tour to the railport facilities in Fryburg and Dickinson.

**New Business:**

Deb Walworth representing GV County Steering Committee requested the City Council consider adding a ½ cent sales tax for the purpose of supporting a medical/wellness center. Discussion. Gerving suggested waiting to make a decision until after the two community meetings being held on February 24<sup>th</sup> and 26<sup>th</sup>. The request will be tabled until the March 3<sup>rd</sup> meeting.

No other business was brought forward. Benes moved to adjourn, second by Gerving. Motion carried unanimously. Meeting adjourned at 8:30 p.m.
