Public Works Report

PWS Braden reported a representative from ND Forest Service was here for a tree assessment. Approximately 60 trees were identified to be removed due to Dutch Elms Disease. The city crew continues to work on street repairs and spraying for mosquitos. Curb side grass and leaf collection is every Wednesday. An Annual Inspection Report from the ND Department of Health was reviewed.

Auditor Report

Nunberg reviewed her written report. Walworth moved to approve a transfer of \$25,000 from General Fund Recreation to the Walking Biking Trail Fund, second by Larson. Motion carried unanimously. There was discussion regarding complaints being received on the parking at the intersection of Hwy 16 and Central Avenue. Marman moved to paint the curb yellow and install No Parking Signs from 1st Ave NW to 2nd Ave NE along Hwy 16, second by Gerving. Motion carried unanimously. Nunberg reviewed the financial report for the month of June. Benes moved to approve, second by Gerving. Motion carried unanimously.

Committee Report

Lagoon Project – Correspondence from City Engineer Jon Wilczek was read.

Street – Marman reported 3rd Street between Central Ave and 1st Avenue SW needs to be excavated to see what is causing the street to sink. Discussion. Marman moved to purchase a packer to be used for street repairs, second by Larson. Motion carried unanimously.

Zoning – Larson reported the Zoning Board will hold a Public Hearing on July 17th at 7p.m. Beach mentioned 4 skid units have been moved into the mobile home park on 5th Avenue NE. Nunberg will follow up on this.

New Business

A Public Hearing was held on an Application for Property Tax Exemption for New or Expanding Business submitted by Ken Stedman and Brad Holtan. No public comment was given. Gerving

abstained from discussion and voting. Marman moved to give a three (3) year property tax exemption, second by Benes. Discussion. Motion carried.

RESOLUTION 2014-12
Setting Auditor Bond Limit

BE IT RESOLVED:

WHEREAS, the City of Beach is covered by a blanket bond by the North Dakota State Bond Fund; and,

WHEREAS, the North Dakota State Bonding Fund provides fidelity bond coverage for city employees and public officials in dealing with public funds; and,

WHEREAS, the bond is fixed by the city governing body and set by resolution as outlined in NDCC §40-14-03; and,

WHEREAS, at the July 7, 2014 regular city council meeting of the Beach City Council the current bond limits were reviewed and found to be sufficient.

NOW, THEREFORE, be it resolved by the City Council of the City of Beach, North Dakota, that the Auditor Bond coverage by the State Bonding Fund in the amount of Five Hundred Seventy-Three Thousand Dollars (\$573,000) has been reviewed and found sufficient.
