**Lagoon Project** – Engineer Jon Wilczek reported design plans were submitted to the ND Department of Health and have been approved. Gerving moved to allow Kadrmas, Lee & Jackson to seek bids for the lagoon project, second by Walworth. Motion carried unanimously.

**Quiet Zone** – Notice has been received that the Quiet Zone will go into effect December 4 at 12:01 pm. Gerving moved to approve payment in full to Kadrmas, Lee & Jackson with the following stipulations; the purchase agreement for the lagoon land purchase can be completed with a warranty deed and the Quiet Zone does in fact go into effect December 4, 2014, second by Walworth. Motion carried unanimously.

### **Unfinished Business:**

A proposal for Growth Planning Services from AE2S was tabled until next meeting.

### **New Business:**

Correspondence from Prairie West Development Foundation regarding building inspections was read. Larson moved to reject the bid in the amount of \$536,268.58 from EHC, LLC for the Multi-Use Trail Project Phase 1, second by Walworth. Motion carried unanimously. Marman moved to approve \$200 in Beach Bucks for full-time city employees and \$100 for part-time city employees, second by Walworth. Gerving – no, Beach – no, Marman – yes, Larson – yes, Walworth –yes. Thank you correspondence from Golden Valley Women in Ag was read.

Gerving recommended following the Snow Removal Plan which was established by the city of Beach in September 2010.

No other business was brought forward. Gerving moved to adjourn, second by Walworth. Motion carried unanimously. Meeting adjourned at 7:50 p.m.
