10. **License Fee:** The license fee to be required of all transient merchants for the transaction of such business within the city, in contemplated and provided for and in by Section 51-04-09 NDCC, is hereby fixed at the sum of one hundred and 00/100 (\$100.00) dollars per day for each and every day during which any transient merchant shall transact business in the city. Such sum shall accompany this application, and be payable in advance for the total number of days applicant shall do business in the city.
11. **Surety Bond:** Before any license shall be issued to a transient merchant for engaging in business in this city, the applicant therefor shall file with the city auditor a bond (See 10.0205 for full Ordinance) running to the city in the sum of one thousand, five hundred and 00/100 DOLLARS (\$1,500.00) executed by the applicant, as principal, and a responsible surety upon which service of process may be made in the State of North Dakota
12. The license issued from the City Auditor's office under this article needs to be posted conspicuously in the place of business. In the event that such person or persons do business in more than one place within the city each salesperson needs to have a copy of the license on them at all times. The person or persons needs to make available to any citizen a copy of said license at the citizens' request.
13. No license issued to a transient merchant in the city shall be transferred.
14. It shall be the duty of the Sheriff of Golden Valley County, and appointed deputies to examine all places of business and persons in their respective territories subject to the provisions of this article, to determine if this article has been complied with and to enforce the provisions of this article against any person found to be violating the same. The city auditor shall deposit with Sheriff a record of each license, together with the location within the city of the business licensed thereunder to assist and promote such enforcement. Failure to abide by the provisions of the Article 10.02 shall be a violation. A violation of the Article shall be punishable by a fine not to exceed \$100 per occurrence.
