A **\$25.00** (twenty-five dollar) non-refundable fee is charged to accounts to reconnect water service. Reconnection service may take up to 48 hours.

**If renter:** A **\$75.00** (seventy-five dollar) refundable deposit is due before services are rendered.

I understand the City of Beach Ordinance requires full payment of water, sewer, and garbage by the **21<sup>st</sup>** of each month. I understand that should my account become delinquent, the City of Beach has the authority to discontinue service to my residence. In the event you are a renter, the City of Beach will notify the owner when the account becomes delinquent. Payments received after the 21<sup>st</sup> of the month are subject to a **\$15.00** late fee which is applied to the next month's water bill. We bill for the previous month's usage.

City of Beach Ordinance requires garbage to be bagged and placed in tippable sanitation carts for street-side collection. The Ordinance Book is available at: [www.beachnd.com](http://www.beachnd.com). If there is not a black sanitation cart labeled **Property of City of Beach** at your residence, or to request an additional sanitation cart, call City of Beach at: 701-872-4103 you may either request another at City of Beach for \$120.00 or you may purchase from another source but it must be tippable and it must have the metal bar on the front.
